

Sign-up Form – CSSC PARK CITY

1. I, the Registrant, request a reservation for the below named ski trip and agree to the following:

a. Sports America Tours, Inc. may omit parts of the itinerary without notice or cancel any flight or bus transportation; may decline or reject any applicant or passenger as a member in the trip. Registrant (and his/her parent or guardian, if registrant is under 18 years, jointly and severally) agrees to pay the sums at the times set forth for the trip. Any increase to cost caused by events beyond the control of Sports America Tours, Inc. or the suppliers and/or its agents including, but not limited to, any fuel cost increase for bus transportation will be passed on to the passenger on a prorated basis and Registrant agrees to pay such increase prior to local departure, but within 10 days of notification thereof.

b. The Ski Club and/or the suppliers have retained a group ski operator, Sports America Tours, Inc. 141 Stony Circle, Santa Rosa, CA 95401, to obtain transportation and land arrangements. Sports America Tours, Inc. and the below named ski club will not be responsible or liable for any loss, damage, accident, injury, delay, failure or irregularities which may occur during the performance or non-performance of, or in any way arising from, any flight or ground services, and Registrant releases the suppliers and Sports America Tours, Inc. for any cause of action arising there from.

c. This agreement is binding upon the heirs, executors, administrators, successors, and assigns of the parties. Should suit be brought to enforce this contract, Registrant agrees to pay reasonable attorney's fees incurred by the Ski Club and/or the suppliers or Sports America Tours, Inc., as set by the courts.

d. It is the Registrant's responsibility to be at the departure point with all necessary travel documents prior to departure time. Passengers who miss the bus/plane whether or not due to circumstances beyond their control (including but not limited to connecting flights, traffic delays, accidents or illness), will forfeit all unrecoverable amounts paid under this agreement.

e. I understand that if by an act of God (i.e., poor weather conditions, road closures, airport closures, etc.) or circumstances beyond the control of Sports America Tours, Inc. or the organization, it becomes necessary to delay or extend the length of the trip; I will be responsible for any additional expenses.

f. Registrant may cancel this agreement if WRITTEN notice is received by the appropriate campus ski club or Sports America Tours, Inc., 141 Stony Circle, Santa Rosa, CA 95401, but no refund will be made until the tours become filled and the passenger is replaced by another eligible member. On all cancellations, for any reason, whether by the individual or group, Sports America Tours, Inc. will have the option of imposing a service charge of \$25.00 per person. In the event a cancellation is received and that space cannot be refilled, the individual is responsible for the above service charge in addition to any and all charges made by the hotel, motel, or condominium; airlines; bus company; rental car agency; or ski area for that cancellation. All additional charges other than Sports America Tours, Inc. service charge will be documents upon request. (For specific cancellation charges, contact the Ski Club) Any name change must be approved by the Ski Club trip chairman and Sports America Tours, Inc. No refund can be made for cancellations of the return bus transportation and/or charter flight. Sorry, no refund for no-shows.

g. Should conditions beyond the control of the Ski Club or Sports America Tours, Inc. demand that the entire Ski Trip be cancelled; every effort will be made to move the ski trip to another location and Registrant hereby expressly agree that this would not be reason for refund. In case the Ski Trip is cancelled altogether for reasons beyond the control of the Ski Club or Sports America Tours, Inc., a fee of \$25.00 per person will be charged to defray the expenses incurred by Sports America Tours, Inc. An additional fee may be charged by the airline, bus company, and/or lodging company. (For specific supplier fee(s), contact the Ski Club).

h. Registrant (and his/her parents or guardian, if registrant is under 18 years, jointly and severally) assumes all of the risks inherent in the skiing/snowboarding activity, all other activities or events on this trip, and travel to and from the ski areas. This waiver, release, and assumption is made with the full knowledge of California Civil Code Section 1542 which reads "A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor", which provision is hereby waived.

2. Registrants agrees to the above with his/her signature on the Agreement /Reservation Form. If the Registrant is under 18 years, his parent or guardian must sign the following form.

3. Final payments not received on time may cause your reservation to be cancelled and forfeit your deposit(s).
